1. GENERAL

This Cookie Policy explains how Neo Custody Ltd. uses cookies and similar technologies when you visit our website located at <https://my.neocustody.com/>.

In some cases, we may use cookies and similar technologies to collect personal information or information that becomes personal when combined with other information. 2. WHAT ARE COOKIES?

Cookies are small text files that are stored through the browser on your computer or mobile device.

The information collected through cookies allows us to determine which parts of our Websites are most visited and identify any difficulties our visitors may encounter when accessing our sites. With this knowledge, we can improve the quality of your interaction with the Platform by recognizing and providing more desired features and information, as well as addressing any access difficulties.

3. WHY DO WE USE COOKIES?

When you access our service Neo Custody Ltd., we may set cookies on your computer or other device. These technologies help us better understand user behavior, and inform us about which parts of our websites people have visited.

4. WHAT TYPES OF COOKIES DO WE USE?

4.1. Strictly Necessary Cookies.

These are cookies that are necessary for the operation of the Website and Platform. Specifically, as an illustration, they include cookies that allow you to access secure areas of the Website and Platform and use certain features (such as logging in and accessing your personal account and portfolio on the Platform).

4.2. Performance/Analytics Cookies.

These cookies allow us to recognize and count the number of visitors and see how visitors navigate the Website and Platform when using it. This helps us improve the functioning of the Website and Platform, for example, by ensuring that users find what they are looking for easily and seamlessly.

4.3. Functionality Cookies.

These cookies allow us to remember the choices you make and to tailor our Services so we can provide relevant content to you. For example, a functionality cookie can remember your preferences (e.g., country or language selection), or your username.

4.4. Targeting/Advertising Cookies.

These cookies record your visit to the Website and/or Platform, the pages you have visited, and the links you have followed. We will use this information to make the Website and Platform,

along with the advertisements displayed on them, more relevant to your interests. We may also share this information with third parties for this purpose.

4.5. Session Cookies.

These cookies contain encrypted information that allows our system to uniquely identify you during the login process. Session cookie files only exist during an online session and are deleted from your computer when you close the browser. This enables us to process your requests and helps us ensure that you are who you claim to be after logging in.

5. HOW LONG HOW LONG WILL COOKIES STAY ON MY BROWSING DEVICE?

The length of time a cookie will stay on your browsing device depends on whether it is a "persistent" or "session" cookie. Session cookies will only stay on your device until you close your browser. Persistent cookies stay on your browsing device until they expire or are deleted.

6. OTHER INFORMATION STORED

6.1. Web server Logs.

For security and troubleshooting purposes our web server stores logs of activity on the website. The information stored includes: date, time, IP, page visited, result, amount of data sent and browser used.

7. WILL THIS COOKIE POLICY BE UPDATED?

We may update this Cookie Policy from time to time to reflect, for example, changes to the cookies we use or for other operational, legal or regulatory reasons. We review cookies every 30 days to ensure accurate reflection of all cookies in this policy. If we do, you will be notified when you first visit our website after the change.
